The Humanity of Humans in the Prophetic Sunnah Universal Values and Sharia Regulations

Praise and Thanks be to Allah, The Almighty and May His blessings be on Mohamed and his family and companions.

Man has been numerously celebrated in various verses in the Holy Quran: a proof of being the perfect creation of Allah that has been honored with reason, knowledge that legitimate him for being Allah's designated successor for the process of populating and reconstructing earth. Privileged with reason, Man has been, thus, entitled to utilize his humanity for the sake of synthesizing material and cognitive production resources with those spiritual ones, while maintaining Allah's universal rules and foundations. However, the tandem of the circumstances has -to a big extent- spoilt man's innate Fitrah or creation and deviated him from the route set by Allah. The cure to this is to be found only in Quran- Allah's Holy book- the Sunnah of his Messenger: Prophet Mohamed. Sunnah has offered clear-cut ways of reviving the inherited values of humanity and providing the human soul with reasons of wellness and fertility. Sunnah works on maintaining deviation from the pure innate nature humans were created with and redirecting humans to the correct pathFor the above reasons, Prophetic Sunnah Research Centre has decided to dedicate its 11th Symposium to the topic of The Humanity of Humans in the Prophetic Sunnah: Universal Values and Sharia Regulations. It is intended to provide a broad material for researchers to come up with different treatments and productive visions and interpretations.

Reasons for Choosing the Topic:

- **1.** The persistence of the materialistic tendency that has transformed the essence of man, making him a deaf machine for material and technological production
- **2.** The limitation of intellectual and philosophical theories to dealing with the material and formal aspect of man, and their inclusion in the spiritual and moral aspect
- **3.** Clarification of the primacy of the Prophetic Sunnah to rooting the universal values that sponsor human humanity, and preserve its spiritual and moral essence, without neglecting the noticeable human difference, and the emergence of the occult specificity of persons

Objectives of the Symposium

- 1. Explanation of the human characteristics of man in the Prophetic Sunnah, its components, and the approach to preserving and rationalizing it
- 2. Highlighting the universal values that sponsor humanity in the Prophetic Sunnah
- 3. Formulating guiding controls for human humanity in its behavioral, intellectual, and productive dimensions
- **4.** Establishing the basis for the legislative superiority of the Prophetic Sunnah in treating human psychological diseases and putting them on the path of adult universal values, through holding analytical balances between the prophetic treatment and the philosophical approach
- **5.** Criticizing the fallacy of intellectual and philosophical approaches to human humanity in light of the remarkable integration between the material and the spiritual aspects, in the light of the Prophet's Sunnah

Conditions for the acceptance of research papers and their publication in the peer- reviewed symposium book

- 1- The research study should be characterized by novelty, originality, depth, and reality.
- 2- The research paper should be characterized by linguistic integrity and a sound academic style.
- 3- The introduction to the study should include review of literature, with an indication of the academic addition provided by the study.
- 4- The research paper should have not been previously published, submitted for publication to a peer reviewing institution. It should be neither used for obtaining an academic degree nor previously presented to another conference.
- 5- The research paper should be closely related to the subject of the symposium and its themes.
- 6- Avoiding over-quotation exaggeration in interpretation as well as verbiage.
- 7- The Qur'anic verses should be quoted as indicated from Al-Madina's Electronic Quran.
- 8- Hadiths should be documented by extracting them from the original sources, and the titles of the book and the chapter should be mentioned, along with the part and page numbers, as follows: Muslim included it in the Book of Sales, The Chapter of the Prohibition of Selling Surplus Water that is in the Desert and is Needed for Pasture Grazing 5/34, with an indication of the degree of hadiths if they are from outside the two Sahihs, and that the text is punctuated according to the Program of the Custodian of the Two Holy Mosques.
- 9- The quotation should be documented by submitting the name of the author, as follows (Ibn Hajar, Fath Al-Bari, 1/210).
- 10-The conclusion should include the results and recommendations of the study.
- 11-The list of references must be at the end of the research paper, arranged alphabetically; the title of the book precedes the name of its author, as follows: Fath Al-Bari Sharh Sahih Al-Bukhari, by Abu Al-Fadl Ahmed bin Ali bin Hajar Al-Asqalani, Beirut, Dar Al-Maarifa. 1379 AH.
- 12-The font size for the research paper should be (16), and for the footnotes (14), in (Traditional Arabic) font, with margins of 2.5 cm on the four sides of the page; the research paper ranges from (20) to (30) pages.
- 13-The researcher is committed to make the modifications requested by the peer reviewing committee and to send the research paper on the specified date.
- 14-E-mail is used for correspondence, to the exclusion of other media.
- 15-Research papers that do not comply with the above conditions will not be considered.
